The training course analyses the content, structure and requirements of EN ISO 14064-1:2018 Greenhouse gases — Part 1: Specification with guidance at the organization level for quantification and reporting of greenhouse gas emissions and removals.

- Environmental Auditors.

By completing the Training Course, participants will be able to understand the basic principles of EN ISO 14064-1:2018 standard, will be able to develop, implement and evaluate Management Systems based on the requirements of the standard and finally will gain experience of practical application through examples and exercises.
